**SUPPLEMENTAL CONTRIBUTORY PENSIONS ORDER, 2009  
AND BOARD OF SUPPLEMENTAL CONTRIBUTORY PENSION (SCP)**

By command of His Majesty the Sultan and Yang Di-Pertuan Negara Brunei Darussalam, Ministry of Finance hereby announces that His Majesty the Sultan and Yang Di-Pertuan Negara Brunei Darussalam has consented for the establishment of an order related to the Supplemental Contributory Pension (SCP) cited as Supplemental Contributory Pensions Order, 2009; and the rules related to it cited as Supplemental Contributory Pension Rules, 2009. The Order and the Rules will commence on 1<sup>st</sup> January 2010.

2 The Order, amongst other things, provides matters connected to the objective and the operation of SCP; the establishment of the SCP Board; the standard and the management of the fund and its investment; the appointment of inspectors; the establishment of SCP Trust Fund; the rate of contribution by employers, employees and Government; SCP and survivorship benefits; and catch-up payment by Government for transition generation.

3 In accordance with section 3 and 4 of the Order, His Majesty the Sultan and Yang Di-Pertuan Negara Brunei Darussalam has also consented to the appointment of SCP Board Members which are as follows:
